## **ABOUT US**

The Club of Rome is a global think tank that deals with a variety of international political issues. It was founded in April 1968 by Aurelio Peccei, an Italian industrialist, and Alexander King, a Scottish scientist. It was formed when a small international group of people from the fields of academia, civil society, diplomacy and industry, met at a villa in Rome, hence the name as The Club of Rome.

CoR consists of current and former heads of state, UN bureaucrats, high-level politicians and government officials, diplomats, scientists, economists and business leaders from around the globe. It raised considerable public attention in 1972 with its report "The Limits to Growth". The club states that its mission is "to a act as a global catalyst for change through the identification and analysis of the crucial problems facing humanity and the communication of such problems to the most important public and private decision makers as well as to the general public." Since 1stJuly 2008, the organization has its headquarters in Winterthur, Switzerland. At present, The Club of Rome has 30 National Associations which includes the number of European nations, USA, Canada, Mexico, Brazil, Puerto Rico, Venezuela, and Asian nations. These associations analyze national, regional and continental problems in terms of the same factors and give advice to decision-makers. The Club of Rome in India is registered as "Indian National Association for The Club of Rome" and was established in 2011. The Indian National Association for CoR India defines a distinct Indian paradigm to address the most pressing concerns of India, South Asia, Asia and the world.

#### B E A MEMBER OF COR- INDIA

- 5. Be an effective **communicator**, understanding the importance of effective communication at all levels and willing to organize CoR- India accordingly.
- 6. Seek creative ways to **connect** CoR-India to the world around him or her, exploring and imagining new forms of partnership and alliances that compliment CoR -India's vision, mission and advance the issues identified in the strategic plans.
- 7. Have a deep appreciation of the strength of diversity, understanding that diversity helps to assure a higher level of responsiveness and promotes creativity, innovation and organizational learning. This is often accomplished by assuring that there are members who have personal experiences that speak to the diversity of the beneficiaries.
- 8. Be **committed to making CoR -India a learning** effectiveness will be greatly enhanced if there are systems, **organization**, practices and structures in place that promote learning on an individual and organizational basis.
- 9. That all members demonstrate the tenets of The Club of Rome on an individual level, with humility and a spirit of service to do what is best for the whole at all times.

# LT GEN ARUN KUMAR SAHNI, PVSM, UYSM, SM, VSM FORMER GENERAL OFFICER COMMANDING IN CHIEF, INDIAN ARMY

A trustee of the Indian Association of the 'Club of Rome'



Lt Gen Arun Sahni is a decorated, scholar – soldier, with 40 years of commissioned service in the Indian Army. He was the General Officer Commanding-in-Chief of one of the six operational commands of the Indian Army, at the time of superannuation.

An alumni of NDA &IMA, he has consistently been a high achiever in his career, starting with the *Sword of Honour and President's Gold Medal*, on being commissioned to the Regiment of Artillery in1976. He has vast *operational experience in active Counter Insurgency operations, both in command* of troops and key staff assignments, as he commanded a Brigade in Counter Terrorist (CT) environ of NE and J&K, Division and later an Army on the western front and an Army Corps in the NE, astride the LAC with China, and borders with Myanmar & Bangladesh. In addition to the conventional responsibility in the NE, he was entrusted with CT Operational responsibility in six of the seven NE States. He was part of the IPKF during Op Pawan (Sri Lanka) and has seen active service in both J&K and NE India. *He was awarded the SM & VSM while in service in operational areas, UYSM for command of the operational Corps in the North East and PVSM for his meritorious service in the army. In addition he has been awarded the COAS commendation Card twice.* 

This vast experience of command and staff in the army, in different operational environments of Sri Lanka, North East and J & K, trainir the British Army, military diplomat in Russia,

tenanting critical key appointments at the apex level of the army, in Military Operations

responsible for looking at force structuring and capability development of the IA and Director

General of Information Technology, coupled with exposure to corporates and academia, has

empowered him to contribute effectively in matters related to strategy, security and defence.

He is an M. Sc (Def Studies), M. Phil (Def & Mgt Studies), M. Phil (Def & Strat Studies) and

currently pursuing D Phil (Doctorate) from Allahabad University.

An active speaker, at various forums and Institutions, he is well respected for his strategic

insight on India's security challenges and emerging international dynamics. He covers a wide

range of subjects with specific reference to National Security, Global & Regional security

trends, terrorism, hybrid W, New age warfare & future security challenges, Af-Pak dynamics,

Information Security, Cyber and related nuances, conflict management', developmental and

security challenges in NE including Act East and experiential leadership & motivation.

Presently 'pro bono', he is mentoring start ups in the domain of cyber, robotics and Al.

Committee of 'National Cyber Safety & Security Standards', Chennai. He is on the managing

board of a well reputed public school in Delhi and a University in Jaipur. A trustee of an
